The shares have no expiration date.

- 3. Reflects a 1-for-12.85 reverse stock split effected on June 11, 2015.
- 4. This option was granted on March 26, 2015 and vests over four years with 25% of the shares vesting on March 26, 2016, and the remaining 75% of the shares vesting in equal monthly installments thereafter through March 26, 2019.
